PRESIDENT'S REPORT

President Jones has been busy with community and legislative work, while also getting to know faculty and staff from across campus. President Jones is focused on continuing to position CWI so people do not just recognize the name CWI, but there is an enthusiasm about future partnerships and ultimately strategic seed planting happening.

NEXT BOARD MEETING March 10, 2022

On a legislative front, President Jones was present when the Joint Finance Appropriations Committee (JFAC) approved \$10 million for the new Health Science building and an additional \$5 million for the relocation and continued development of the Horticulture program. There will also be CEC money made available.

- Covid 19 Update The Seal Team has done a great job keeping this institution safe and protected through the COVID 19 Pandemic. President Jones would like to solicit the Trustee's input on transitioning to "Masks Optional", effective Monday, March 14. Vice Chair Buckner-Webb and Trustee Hightower both expressed their support of this action.
- The Commencement Planning Committee is happy to announce CWI Graduation will be in-person, (and live streamed) on Friday, May 13 at 7:00 p.m. at ExtraMile Arena. President Jones is very excited to take part in his first CWI graduation.
- CWI is partnering with Amazon and their "Career Choice" Program. Amazon will prepay 100% of tuition for their "tier-one" employees to attend CWI.
- General Council Fontaine referred to Governance Policy Section 5.2 regarding the Vice President of Advancement position. It would make more sense to have President Jones Chair the Search Committee, as well as appoint members of the Search Committee, using the Page Up process in collaboration with Human Resources.

Trustee Hightower asked if the Trustees should look at Board Governance Policy 5.2 going forward, to be more in line with peer institutions. General Counsel Fontaine stated it would be worth revisiting in the future.
